As a player on tour either internationally or domestically, I hereby agree to accept membership of the team, on the following terms and conditions.

Conditions

1. I agree to abide by the following conditions:
 - 1.1 My obligations under this agreement shall take precedence over my obligations under any other agreement for sponsorship or any other matter in conflict with this agreement that I may have entered into.
 - 1.2 While participating or traveling as a player in the team I will comply with all lawful directions of the Head Coach, the Team Manager and other staff members.
 - 1.3 While participating or traveling as a member of the team, I will ensure that my behaviour is proper and such as would be expected by the Mornington District Basketball Association and the Mornington Breakers when representing it. Without limiting the generality of that statement, specifically I will comply with Basketball Victoria's Codes of Conduct, By-laws and any other Mornington District Basketball Association policies (a copy of which is available at Basketball Victoria's offices or morningtonbasketball.com.au).

- 1.4 I acknowledge I am responsible for my share of the players' contribution or fundraising for the team. Any amount fund-raised (as distinct from paid by me) will not be refunded if it becomes impossible for me to take my place in the team through injury or other circumstance. If it appears that there will be a shortfall in the amount necessary to cover on the ground expenses, I will be notified and advised of the amount of the shortfall and agree to cover my share of that shortfall.

Rules

2. I will comply with the following rules at all times when participating or traveling as a member of the team.
 - 2.1 Use or consumption of alcohol or tobacco products or drugs (other than for medical purposes) is prohibited at all times while participating or traveling as a member of the team. This includes end of tour parties.
 - 2.2 No male may enter a female's room not any female enter a male's room. No person other than the persons allocated by the team and team officials may be allowed to stay in the accommodation. This applies at all times.
 - 2.3 Intimate relationships (whether or not of a sexual nature) between players and staff members are prohibited.
 - 2.4 Any curfew set by team management must be obeyed at all times.
 - 2.5 No player may provide any information to or conduct any interview with a representative of the media about the team without express approval of Mornington District Basketball Association.
 - 2.6 All players shall attend and be punctual for all team training sessions, meetings, games and travel arrangements.
 - 2.7 All moneys due as a member of the team including clothing, travel and other costs shall be paid to the relevant party by the player prior, to the tour in which the player is engaged.
 - 2.8 Players shall immediately disclose to the Team Manager any illness or injury suffered. If the injury or illness occurs while the team is overseas, the player may be sent home immediately at the sole and absolute discretion of the Team Manager at the player's expense.
 - 2.9 On all occasions when required by the Team Manager, players must wear their team uniform and be neat and tidy at all times.
 - 2.10 Players shall comply with all Commonwealth, State or local laws at all times while a member of the team.

Injury Loss or Damage to Persons or Property

3. If I cause injury, loss or damage to any other person or property in any way, I shall pay for that injury, loss or damage as required by law and I shall keep Mornington District Basketball Association its servants and agents indemnified against such injury, loss or damage unless such injury loss or damage was covered by an insurance policy.
4. If I am injured or suffer loss or damage to property, Mornington District Basketball Association, its servants and agents shall not be responsible for such injury, loss or damage whether or not such injury, loss or damage was caused by Mornington District Basketball Association or its servants and agents, by negligence or otherwise, unless such injury loss or damage was covered by an insurance policy.

Breach of Conditions and Rules in this Agreement

5. If I breach any of the conditions or rules contained in this agreement I understand that I may be subject to all or any of the following measures:

- Expulsion from the team at the sole and absolute discretion of the Team Manager or Mornington District Basketball Association.
- Immediately be sent home at the sole and absolute discretion of the Team Manager or Mornington District Basketball Association and at my own expense.
- Referral of my conduct to a hearing by Tribunal.
- An investigation under the Basketball Victoria Tribunal By-laws.

GUARANTEE FOR PLAYER UNDER 18 YEARS OF AGE

I also agree to pay all money due by the player to the relevant body organising the event, its servants and agents or any other person under this agreement or arising out of the player's involvement in the Team.
