As a Team Manager on tour either internationally or domestically, I hereby agree to accept membership of the team, on the following terms and conditions.

Conditions

Email

- 1. I agree to abide by the following conditions:
 - 1.1 My obligations under this agreement shall take precedence over my obligations under any other agreement for sponsorship or any other matter in conflict with this agreement that I may have entered into.
 - 1.2 Whilst participating or traveling as a manager of the team, I will ensure that my behavior is proper and such as would be expected by Mornington District Basketball Association when representing it. Without limiting the generality of that, specifically I will comply with Basketball Victoria's Codes of Conduct, By-laws, policies and any other Mornington District Basketball Association's policies (a copy of which is available at Basketball Victoria's offices or morningtonbasketball.com.au).
 - 1.3 I will enforce the Team Players and Staff Agreements honestly and reasonably and to the best of my ability and so as not to bring Mornington District Basketball Association and Basketball Victoria into disrepute and in the best interests of the players and staff in the team.

Rules

- 2. I will comply with the following rules at all times when participating or travelling as a member of the team.
 - 3.1 Intimate relationships (whether or not of a sexual nature) between managers or coaches and players can have harmful effects on the individual player involved and on other players. Such relationships may be perceived to be exploitative because there is usually a disparity between managers and coaches and players in terms of authority, maturity, status and dependence. Given there is always a risk that the relative power of the manager or coach has been a factor in the development of such relationships, they must be avoided by managers and coaches at all levels. In the event that a player attempts to initiate an intimate relationship, the manager or coach must take personal responsibility for discouraging such approaches, explaining the ethical basis for such actions. No matter what age the manager or coach and player are, Mornington District Basketball Association prohibits such relationship between managers or coaches and players in the teams which they are managing or coaching.
 - 3.2 I shall attend and be punctual for all team training sessions, meetings, games and travel arrangements.
 - 3.3 All moneys due as a member of the team (if any) including clothing, travel and other costs shall be paid within the required timeframes.
 - 3.5 I shall not accept a Team player not from my own club/association into my club/association without approval from Mornington District Basketball Association, which approval shall be given only in exceptional circumstances.
 - 3.8 I shall comply with all Commonwealth, State or local laws at all times whilst a member of the team.

Injury Loss or Damage to Persons or Property

- 3. If I cause loss or damage to any other person or property in any way, I shall pay for that loss or damage as required by law and I shall keep Mornington District Basketball Association, its servants and agents indemnified against such injury, loss or damage.
- 4. If I am injured or suffer loss or damage to property, Mornington District Basketball Association, its servants and agents shall not be responsible for such injury, loss or damage whether or not such injury, loss or damage was caused by Mornington District Basketball Association or its servants and agents, by negligence or otherwise, unless such injury loss or damage was covered by an insurance policy.

Breach of Conditions and Rules in this Agreement

- 5. If I breach any of the conditions or rules contained in this agreement I understand that I may be subject to all or any of the following measures:
 - Expulsion from the team at the sole and absolute discretion of the Coach or Mornington District Basketball Association.
 - Immediately be sent home at the sole and absolute discretion of the Team Manager or Mornington District Basketball Association and at my own expense.
 - Referral of my conduct to a hearing by Tribunal.
 - An investigation under the Basketball Victoria Tribunal By-laws.
